CONQUER NEPAL is an organization established only for the development of the Nation. Not only pointing out the problems, faced by the country in the different sectors like education, health etc., C.N targets to overcome those entire problems as far as possible.

## Objectives of Organization

> To provide education and organize the activities related to social welfare and personality development of youth, women, child and adults
$>$ To advocate for the protection of human right.
> To provide vocational training for the citizens.
> Advocacy of local resource, materials and production

## Program Goal/ Objective:

> To provide computer education to the students of class 8,9 \& 10 .
$>$ To create skilled and expert human resource in the field of IT.
> Establishment of Resource and research Center
$>$ Establishment of IT based computer institute in different districts and locations and providing them the best and skilled teacher to train them.


## A. Roles and responsibility of CN :

$>$ Program implementation will be coordinated with the District Education Offices using CN's resource, school resources shall not be used.
$>$ Funding the program: for essential equipment, management of Human Resource
> Commitment that the program shall support schools and students; the education of school shall not be hampered and school shall not have to bear any economic burden and other.
$>$ Coordination with schools and assist schools and students
> Management of CN Human resource for the program
> Management of appropriate time for students and Schools
> Personality and Leadership Development Program implementation
$>$ Reporting to concerned LEOs, REDs and DOE.

## B. Roles and responsibility of DOE:

> Coordination and relevant support for the program
> Verification, monitoring and evaluating the progress report

## C. Mutual Agreement:

$>$ Exchange of technical ideas, information and expertise will be carried out as per program need.
$>$ Activities will be designed and implemented jointly after assessment of achieved output.
$>$ Other forms of cooperation will be carried out as agreed by the parties, including meetings between the two Parties on a regular basis
$>$ This MOU shall enter in force upon signature by both Parties and remains in force for a period of five (5) years from the date of agreement, unless terminated earlier by either Party upon ninety (90) days, written notice to the other Party.
$>$ With reference to the program achievements, CN and DOE will extend the time period.
$>$ Nothing in this Agreement is intended to conflict with current laws or regulations Govt. of Nepal. If a term of this agreement is inconsistent with such authority, then that term shall be invalid, but the remaining terms and conditions of this agreement shall remain in the full force and effect.

$>$ Any issues arising from the interpretation or implementation of this MOU will be settled through consultations between the parties or such other means as they may mutually decide.
$>$ This MOU is the complete agreement between DOE and CN may be amended only by written agreement signed by each of the parties involved.
